At the very outset we place on record our appreciation for this matter having been brought to this court in public interest with the object of securing morphine tablets freely for the benefit of cancer patients or any other patient in genuine medical need of morphine. From what is stated in para-11 of the affidavit of Dr.Ghooi it seems that the filing of this petition has resulted in disposal of applications filed by some hospitals for obtaining the license to get morphine tablets for the said hospitals. We have no doubt that henceforth whenever an application for license is preferred it will be disposed off expeditiously by the authorities. Any delay in disposal of the application would be viewed very seriously. It would be open to the licensee to approach the court and seek appropriate directions in case of undue delay. Further we hope that the doctors and chemists ie, licensees would be made available the requisite quantity of morphine tablets according to their quota and requirements so that in turn the same can be made available to the patients.
