# **Board of Trustees**

He founded Pallium India in 2003, with a mission to catalyse and facilitate the integration of palliative care with healthcare in India. In 2018, the Indian Government honoured Dr M. R. Rajagopal with the Padma Shri award.

# **About Palliative Care**

In much of history, the reduction of suffering was at the core of medicine. As medical science evolved and better diagnostic and treatment modalities became available, the focus shifted to successful treatment and cure of diseases and illnesses. While this benefited humankind in countless ways, we started losing sight of the fact that not every illness can be treated beyond a point, however patients living with serious health related suffering and nearing the end of life, are also deserving of care. There has been unintended neglect and marginalization of palliating health-related suffering. Palliative Care Services continue to be severely inadequate in India.

# **About Pallium India**

Pallium India works to integrate Palliative Care with all healthcare, through demonstration, education and facilitation.

Pallium India (www.palliumindia.org), a Non-Governmental Organization, has been a pioneering organization in the field of Palliative Care in India. In line with principles of Universal Health Coverage we are committed to reaching the patient where they are and when they need it. A model of care where palliative care services are delivered by a healthcare team in the patient's home was established to complement facility based care. This is particularly important as many patients may not be mobile and cannot come to the hospital. Our TIPS and home care teams currently deliver care to over 4000 patients a year.

#### Vision

An India in which palliative care is integrated into all health care so that every person has access to effective pain relief and quality palliative care along with disease-specific treatment and across the continuum of care.



#### Mission

To catalyze the development of effective pain relief and quality palliative care services and their integration in health care across India through the delivery of services, education, building capacities, policy, research, advocacy and information.

#### Core Values

The patient is the most important consideration. Commitment to Pallium India will be secondary to a commitment to the patient and family.

- Care is the right of the patient and family and we stand committed to giving it to them.
   Care is not a charity that we give them. By allowing us to care for them, they are enriching our lives.
- Compassionate and competent care valuing human dignity is at the very heart of what we do and why we exist. We shall endeavour to do the right thing for the right reason as best as we can
- We recognise the strength of the social capital and shall engage in a partnership with the
  community enlisting the support of volunteers and other community entities, creating the
  capacity to meet community needs. Each one of us shall treat everyone else with respect,
  remembering that every individual is superior to each one of us in some way.

# Our Work- Facilitation

#### **National Outreach**

#### Implementation of the National Program of Palliative Care

The Ministry of Health and Family Welfare, New Delhi, in collaboration with the Government of Tamil Nadu and WHO India, organized a review meeting on 4-5 November 2019 in Chennai. The meeting called upon attendees to share their experiences, collate best practices in palliative care in India, and discuss the implementation of the National Program of Palliative Care (NPPC).

The programme was a part of the National Health Mission (NHM) and has a vision of ensuring the availability and accessibility of quality pain relief and palliative care to the needy. Dr Rajagopal was a member of the Expert Group.

# Work with the Government of India for implementation of the amendments to the Narcotic Drugs and Psychotropic Substances Act.

Pallium India engaged with the Government of India's Department of Revenue and Ministry of Health to facilitate the appropriate revision of the "State Narcotic Drugs and Psychotropic Substances Rules" and create simple, standard operating procedures for state governments to follow. The State NDPS Rules which were announced in May 2015 need revision because of several gaps. This involves working with both the Department of Revenue and the Ministry of Health of the Government of India.

- We had three meetings with officials of the Department of Revenue. Discussions are ongoing.
- We had two meetings with the Ministry of Health and Family Welfare.

Work with the individual state governments for implementation of the state rules of 2015, under the Narcotic Drugs and Psychotropic Substances Act in collaboration with local pioneers.

In India, health is a "state" subject and it is necessary to work with 29 State Governments and 6 union territories to ensure that the amendments to the NDPS Act are implemented without bringing in additional barriers. We propose to work in 1-2 states every year, selecting states in which palliative care pioneers can be found who can collaborate with the WHOCC. In the selected states, we propose also to educate professionals by working with the State Departments of Health and with the National Medical Commission for the introduction of palliative care into the medical curriculum. It is also proposed to work with the State Department



of Health and with the state representatives of the National Health Mission to ensure implementation of the National Program Palliative Care (NPPC). In each state, a review of barriers will be performed to ensure that the amended regulations are implemented.

- Conducted opioid availability workshops involving officials and palliative care doctors and other activists in Jammu and Kashmir on the 27th of July 2019.
- Worked with state champions in Uttarakhand, Goa, AP, Puducherry, Meghalaya.
- Key officials educated about opioid access in-depth in Jammu and Kashmir.
- Approval of Recognised Medical Institutions following new NDPS rules became a reality in 4 states and 1 union territory:
  - Haryana (district hospitals
  - Himachal Pradesh (district hospitals)
  - Uttarakhand (Ganga Prem Hospice)
  - West Bengal (Ruma Abedona Hospice)
  - Goa (Dilasa Hospice)
  - Andhra Pradesh (Age Care Foundation)

#### International Level

#### Access to Internationally Controlled Essential Medicines

The Director -Programmes of Pallium India has been part of a group of international experts to discuss common barriers to accessing Internationally Controlled Essential Medicines(ICEMs) for low-and middle-income countries (LMICs), to study barriers to accessing ICEMs across care fields like anesthesiology, epilepsy, harm reduction, mental health, and pain and palliative care.

# WHO guideline development group

Dr. M.R Rajagopal has been selected as a member of the WHO Guideline Development Group or Expert Review Group for the review and update of the WHO Guidelines on the pharmacologic treatment of persisting pain in children with medical illnesses published in 2012.

The role of members of the WHO guideline development group is to advise WHO in the interpretation of the evidence for making recommendations taking into consideration: (i) desirable and undesirable effects of this intervention; (ii) the quality of the available evidence; (iii) values and preferences related to the intervention in different settings; and (iv) the cost of options available to health-care workers in different settings.



# Our work- Education

#### **Onsite Training:**

To increase awareness of palliative care amongst health care professionals, we conduct training programs in Trivandrum. Pallium India is running six weeks' Certificate Course in Pain and Palliative Medicine (CCPPM) for doctors, Certificate Course in Palliative Nursing (CCPN) for nurses and Certificate Course in Palliative Care (CCPC) for other healthcare workers respectively. Pallium India conducts 10 days' Foundation course in Pain and Palliative Medicine (FCPPM) for doctors and nurses. Also conducts a 3 days training program for volunteers.

In addition to TIPS, Certificate Course in Pain and Palliative care is carried out by other three centres catalyzed by Pallium India. These are MNJ Institute of Oncology, Hyderabad, Gujarat Cancer Research Institute and BMCHRC, Jaipur. Pallium India coordinates the fellowship program in palliative care offered by Indo-American Cancer Association (IACA).

TIPS has been training medical professionals in Palliative Care since 2007. Courses we offer:

- Six Weeks Certificate Course in Pain & Palliative Medicine (CCPPM)
- Six weeks certificate Course in Palliative Nursing (CCPN)
- Ten Days Foundation Course in Pain & Palliative Medicine (FCPPM)
- Ten Days Foundation Course in Palliative Nursing (FCPN)
- Volunteers Training Program (VTP)
- Training the Trainer programs



#### **Online Training**



Project ECHO® is an online lifelong learning and guided practise model that revolutionizes medical education and exponentially increases workforce capacity to provide best-practice speciality care and reduce health disparities through its hub-and-spoke knowledge-sharing networks.

To spread the knowledge of palliative care and attain more expertise in the medical field, TIPS collaborated with ECHO India to widen the horizon and thus initiated TIPS-ECHO. Through the TIPS-ECHO platform, TIPS looks forward to building the capacity of healthcare professionals and spreading awareness among the masses. TIPS-ECHO Program helps to connect, assess, monitor, support and educate palliative care teams across the country.

All levels of providers including Physicians, Nurses, and Allied health-care providers (including pharmacists, psychologists, social workers, occupational therapists, physiotherapists, play specialists, and others) and beneficiaries of Palliative Care can be a part of TIPS-ECHO training.

# **Project Aarohan**



# **AAROHAN**

Giving Voice to Lived Experiences



With generous support from the Worldwide Hospice and Palliative Care Alliance (WHPCA), we launched Project Aarohan – Empowering the voices of those who suffer".

The word Aarohan means "to rise", and through this project, our aim was to strengthen the voice of direct palliative care beneficiaries (i.e: people and caregivers who are

currently living with conditions that require palliative care now or may require it in the future), and improve their impact as advocates to improve access to quality palliative care in their communities. This was in line with WHPCA's vision to improve the power balance and dynamics and look at who is speaking on behalf of whom to develop a more impactful social justice movement on palliative care in low and middle-income countries, and worldwide.

We conducted online sessions using the ECHO (Extension for Community Healthcare Outcomes) platform over 5 months, wherein 20 selected participants were familiarised with various aspects of advocacy, related strategies and tools.



# **Other Trainings**

#### A Visit to Timor Leste

Pallium India's Director- Programmes visited Timor Leste in August 2019 for conducting a training needs assessment to support the capacity building of palliative care services in the country. This was followed by a 10-day long training visit of a 3 member delegation including two nurses and a doctor, to the Trivandrum Institute of Palliative Sciences in October 2019.

#### Timor Leste team in India

- 1 Doctor and 2 nurses Dr Celestina, Sr. Epifania and Mr Antonio visited TIPS from 21st October 2019 to 30th October 2019 for exposure and training on the model of care delivery provided in Trivandrum, via community-based home care, in-patient and outpatient units.
- The 10-day hands-on training was provided to the Timor Leste team.
- They were oriented to the services and activities at the TIPS facility and accompanied the TIPS teams into rural as well as urban home care settings and OPDs. Specific emphasis was given to nursing-related issues and pharmacy management, keeping in mind the competencies and the requirements of the two nurses, as well as the issues of procuring, stocking and dispensing Essential Narcotic Drugs (ENDs) back in Timor Leste, as identified during the Director-Programmes' visit.


#### Trainee Tracking

45 doctors were given hands-on training during the 2019- 2020 period to doctors from Kerala, Andra Pradesh, Himachal Pradesh, Uttar Pradesh, Tamil Nadu, Karnataka, Nagaland, Maharashtra and Pondicherry. From the 2019 batch, we have effectively launched a feedback form (online) to assess their palliative care practice. This tracker is also used to analyse the feedback of previous year batches.



#### Home Care

Home Visits form a crucial part of our services. There are thousands of people who cannot access a healthcare facility because they are bed bound, elderly, living alone with no one to accompany them or geographically isolated. At Pallium India, we strive to meet them, where they are, when they need us, honouring the Universal Health Coverage tenet of leaving no one behind.










#### In- Patient (IP)

In-patient services are available at the Trivandrum Institute of Palliative Sciences and delivered by a Multidisciplinary Team involving Doctors, Nurses, Medical Social Workers, and Physiotherapists. Patients are admitted for short or long term symptom control as well as for hospice services to facilitate appropriate end of life care.

# Rehabilitation and Psychosocial Care

Pallium India is committed to improving the overall quality of life of patients and families. We recognise that illness-related suffering has many aspects – physical, mental, socio-economic and spiritual. Therefore, rehabilitation services form an integral part of the support we offer. This has several components and programmes under it:

# Halfway Home

Pallium India runs a unique "Halfway Home" Programme where patients with spinal cord trauma are housed and rehabilitated in a facility that includes a kitchen, a wheelchair accessible room, and restroom so they can be trained in using these facilities before they are sent home. This year a total of 11 beneficiaries were admitted in Halfway Home.

# **Projects**

# Ujjwal

With generous support from the Federation of Malayalee's Association of America (FOMAA), we launched Project 'Ujjwal'.

Through this project, our aim is to strengthen the women caregivers, thereby empowering them and promoting gender equity. We provide vocational and psychosocial support for caregivers of patients, to prevent complete financial destruction as well as to combat caregiver burnout.

Through project 'Ujjwal' we provide support to women beneficiaries' vis-a-vis aid for basic food, water and shelter, vocational support, medical/ procedural support, educational support for the children. 44 families have benefited through this project.

#### Kuttikootum



Loosely translating to "Children's Collective", our Kuttikootam programme supports the educational needs of children whose families have been financially destroyed by health related expenditure.

Very often, one of the first collateral damages seen in a family navigating a serious and chronic health crisis is the discontinuation of the children's education, as those funds are reallocated to treatment costs. At Pallium India, we try and ensure that children do not slip through these cracks. We also run summer camps for children listed under this programme, where they share experiences, make friends and learn life skills. This year we have supported 287 children through this initiative.

#### Unary

Unarv is a bereavement support group for families who need psychological support to address and work through their grief following the death of their loved ones. This group is driven by a volunteer team who meet once in a month along with the family members of Unarv. A total of 70 beneficiaries have been attending Unarv on a regular basis.



# Facilitation - State level

Volunteer/ civil society engagement at state level.

- By 2019, we have initiated 149 palliative care clubs under Kerala University in collaboration with National Service Scheme in 6 regions of Kalam Technological University (KTU). Last year, we initiated 15 palliative care clubs in collaboration with Student Police Cadets (SPC) In Trivandrum.
- In addition, close to 120 volunteers have registered with Pallium India for COVID relief work. This is in addition to the existing 100 active volunteers.
- As part of pallium India compassionate community for care campaign we have sensitized 5000 public in different locations of Venganoor, Poovar grama panchayats and last year we have developed 3 new centers under compassionate community there are Ranigiri compassionate community, Life care pain and palliative care, Bharathannoor and Thanal charitable trust Kaniyapuram.
- Pallium India is an active member of Indian Association of Palliative care, a national professional organisation of palliative care professionals in India.
- Pallium India along with other palliative care civil society organisations meet every month under the umbrella of Thiruvananthapuram Initiative in Palliative care.
- We are associated with IMA, Indian Association of Palliative Care India (IAPC), Indian Association of Palliative Care India Kerala Chapter, Thiruvananthapuram Initiative of Palliative Care (TIPC), Kerala Association of Professional Social Worker (KAPS), National Service Scheme (NSS) for college level student Initiative in Palliative care. Student Police Cadet (SPC) at school level. Association with Social Workers College in Kerala (especially Loyola extension center). Federation of Residents Association in Trivandrum (FRAT), Social Justice Department (SJD), Kerala Social security Mission (KSSM). Association with individual clubs like Lions club, Rotary club, Freemason club, Sreemoolam club, Trivandrum Club, Inner wheel, Manaveeyam theruvora kuttam, Indus cycle embassy, Blood donors Kerala, NILA, NISH, Kanthari, Pradidwani (A welfare organisation for techno park employees), Program Management Institute(PMI), Red Cross Society, , Ashrya theeram (patient rehabilitation center), Karunya Vishranthi Bhavan Kattayila, Marthoma Guidance Center, YWCA, YMCA and Bank employees Union(officers forum).
- Pallium India is a part of Interagency group (IAG) under Kerala state disaster management authority.



#### Revision of Kerala Policy of Palliative Care

The Pallium India team met the Health Minister of Kerala on the 1st of August to propose changes in the existing Palliative Care Policy which was created in 2008. The Health minister called for a workshop with representation by Palliative Care experts across the state. The 2 day workshop resulted in a revised draft policy which was submitted to the Health Minister and Health Secretary for further review. On September 16th, all Government officials from the Health Department got together to review the revised policy and suggest changes. The revised policy was announced on 13th December at the eve of Universal Health Coverage Day. The new policy had significant changes with the focus on secondary and tertiary healthcare, livelihoods, roles of NGOs and CBOs to name a few. The action plan of the revised policy is yet to be formulated.

#### Community Engagement

We believe that Community engagement is the essence of Palliative Care and that health for all is health with all, and that for it to be sustainable, it must be owned by the community.

To this end, we initiated the following programmes aimed at Community engagement.

- Compassionate Communities
- SANS Pain Students' Palliative Care initiative
- Unarv
- Volunteer programme

We also conduct events like 'Patients Get together', 'Life and Death with Dignitea', food festivals, flash mobs, exhibitions and sales of patient-made products over the course of the year, as well as on occasions like World Hospice and Palliative Care Day and Elisabeth Kubler Ross's birthday.

Over 150 active volunteers have been catalysed to promote awareness and build demand at the individual and household level in Trivandrum. We also catalyse the panchayats and volunteers within our link centers

Nationally, members from Pallium India have addressed members of civil society at various events like TEDx talks, Rotary meets, colleges and so on.




